Dear Prairie Children Preschool Parents & Alumni:

It's time to complete your alumni application for the 2024-2025 school year! Prairie Children Preschool's alumni application is for **families with current and former students and their siblings**. The alumni application is for students applying for the **TUITION PROGRAM ONLY**.

Students with an Individualized Education Plan (IEP) DO NOT need to complete the alumni application and will receive instructions to complete an online registration in April 2024.

- Please complete the attached alumni application form, **one for each child applying for the tuition program**.
- Please include **a non-refundable \$30.00 application fee, cash or check only**, for each child applying.
- The alumni application form and fee are due by **Thursday, December 7, 2023**.
- Forms can be returned via backpack mail, regular mail, or dropped off in the white bin outside Door #1 at 780 Shoreline Drive, Aurora, IL 60504.

Any alumni application received after **December 7, 2023** will become part of the open application/lottery process which begins in January. This means your student will **NOT** receive priority placement into the preschool for the 2024-2025 school year.

A confirmation letter with your session assignment will be sent to you in **April 2024** with instructions on when to complete the online registration in ParentVue. During online registration residency information will be required if your child has not been third party verified by the district. First day of school information, such as teacher assignment and Meet & Greet details will be sent in August 2024. We are looking forward to another year of providing quality preschool services to our young children in District 204.

Requirements

Students must be three or four years old by September 1st of the current school year.

Families must be current residents of Indian Prairie School District 204 at the time an application is submitted.

General Information

Students attend either a morning session held from 7:50 am to 10:20 am or an afternoon session held from 12:10 pm to 2:40 pm. Students cannot attend both the morning and afternoon sessions. Days are Monday through Thursday. There is no school for tuition students on Friday. The Preschool follows the Indian Prairie School District 204 School Calendar. Students must provide their own transportation. Bus service is not available. Before and after school care is not provided.

To apply for the tuition program, a **non-refundable** \$30.00 application fee, cash or check only, must be submitted with the application. **Checks should be made payable to Prairie Children Preschool.**

The monthly cost of the program is as follows:

- 4 Day Program - \$245/month (***Rates subject to change for the 2024-2025 school year.***)
- A 15% discount off the monthly fee is applied to each additional sibling attending simultaneously.

A confirmation letter with your session assignment will be sent to you in **April 2024**. The tuition deposit payment and online registration will be due by **May 15, 2024**, in order to secure your child's placement. **The tuition deposit payment is non-refundable and will be applied to the last month of tuition in May 2025 only.** The remaining eight installments are due on the first school day of each month, September through April. If the student withdraws for any reason after registration is completed, the tuition deposit payment will be forfeited.

Refunds cannot be made for any absences, including illness, vacation, extended vacation, family visits, emergency weather days or moving out of district. If you choose to leave Prairie Children Preschool before or during the school year, no refund will be given for the fees already paid, and the May 2025 deposit payment is forfeited and cannot be used to pay any outstanding tuition due. **In the event of an extended vacation, you will need to continue your monthly tuition payments if you plan to return to the preschool after the vacation.**
